**Where:** Mizner Park, Plaza Real, Boca Raton  
**Eligible:** All Signature Members  
**Application Fee:** There is no fee.  
**Penalty Fee:** There is a \$25.00 penalty for late cancellations and no shows.  
**Application Due Date:** **April 23, 2008**

## Guidelines:

- Each artist can display up to eight pieces of artwork depending on the size.
- If we get more applicants than places to set up we will randomly pick from a hat and put the remaining applicants as first choice in the following art walk.
- Artist to supply their own display set up, but if using a table, it must be covered in a black or white tablecloth and skirt to the floor.
- Displays can be rented— inquire art walk coordinator
- The area where an artist displays their work will be determined by the coordinator of the art walk.
- Pick Up Artist Packets 5 PM in Images Gallery
- Set Up displays between 5 & 5:45 PM
- Mizner Park does not allow sidewalk sales, but each artist can discuss their artwork and inform patrons that the artwork is for sale and can be purchased that night
- Each artist **MUST** display their Number, Name and The Artists' Guild sign prominently.
- Displays cannot start to be dismantled until **AFTER** 9 PM
- No loud colored lawn chairs, if folding chair needed let coordinator know
- 15% of all Sales will go to Boca Raton Museum of Art
