1. Application must be received by **March 31, 2008 - \$30.00 Entry Fee**
2. **Eligibility:** Signature Members of the Artists' Guild
Each artist will be able to display a full body of work (5 to 8 pieces depending on size)
Original Artwork Only.
3. **Selection of Artists:** April 3 – 8 two D Artists and 2 to 3 sculptors will be selected at random from received entries. Artists not selected will be placed in front of the queue for selection for the following exhibition. The entry fee will only be deposited when you are selected. There are two additional shows now planned using this small group show format.
4. **Important Dates and Times:**
Delivery of artwork by selected artists April 6 – 10:30 to 11:45 AM
Final Pickup of Artwork on July 6 – 10:30 to 11:45 AM
5. **Rules for Hanging and Presentation of Artwork:**
Each artist is responsible for hanging their art in the area designated by the Guild coordinator. Some limited assistance will be available for hanging of artwork.
The Guild coordinator will have final say on placement of all artwork.
GALLERYone reserves the right to reject any artwork deemed objectionable or disturbing.
Artists may replace work during the show if a piece is needed for another venue. Ari Hirschman must be contacted (see contact information) before art is replaced.
Selected artists to supply Guild Coordinator with Title Card Info: Artist Name, Title of artwork, Media, and Price for each piece of artwork and an 8-1/2x11 Bio/Info sheet.
All artwork must be for sale – 10% of all sales to benefit the Boca Raton Museum of Art.
6. **Awards:** The opportunity to display a body of work at a prominent, well attended location.
