- Dates** - Take-in will be **Sunday, June 8, 2008**. Delivery times are 9:30am to 10:30am for 3D works and 10:30am to 11:45am for 2D works. There will be an initial \$25 storage fine for work left in the gallery after the 2nd Tuesday of the show which is June 17, 2008.
- Deadline for Entry Forms and Calendar** - This entry form must be **RECEIVED by Friday, May 30, 2008**. No entries will be accepted after this deadline. There will be no changes in the title, price or medium after this time.
- Eligibility** - Signature Members. The non-refundable entry fee is \$30.00. Enter 2 main and 3 bin pieces. All entrants must have attended gallery training and have all fees paid current.
- Rules** - The most current rules on the web site apply. Please read them as they continually evolve along with our changing circumstances. The Rules that pertain to size for BOTH Main Entries AND BIN Entries are very important as are the requirements for presentation quality.
- Special Take-In** - If you are not able to come to Take-In, you may bring your work to the gallery before hand and pay an additional fee of \$10. The Special Take-In form is also located on the web site.
